Modified Field Areas.

HQrs CGDA, Delhi Cantt vide their letter No. AT/VII/7279/Ration to Defence Civ dated 21.01.2020 has forwarded a copy of GOI, MOD letter No.4(6)/24(6)/2000/D(Civ I) dated 21.09.2000 regarding Admissibility of Concession/Allowances to Civilians paid from Defence Service Estimate working in the Defence Establishment located in Field Areas/Modified Field Areas.

As per GOI, MOD ibid letter dated 21.09.2000, Para 2(A)(a) free rations are entitled to the Civilians paid from Defence Service Estimate working in the Defence Establishment located in Field Areas on scale applicable to combatants of the Army or Air Force as the case may be and fuel.


In this regard, it is stressed upon that the Field Service Concession of Free Ration has not been extended to the Defence Civilians paid from Defence Service Estimate working in the Defence Establishment located in Modified Field Areas as per the GOI, MOD letter dated 21.09.2000. However, cases have been come to notice where Free Rations are regularly been issued to Defence Civilians deployed in Modified Field Areas. So, it is directed to all the Local Audit Authorities to keep a constant vigil and when ever such irregularities come to notice, the same should be objected to & money should be recovered at the earliest.


