Subject: Carry forward of Leave Balance of a Defence Civilian employee on transfer/appointment/promotion from Non-Industrial to Industrial Establishment

The matter has now been examined in consultation with Department of Personnel & Training and it has been decided to allow Defence Civilian employees, on their transfer/appointment/promotion from Non-Industrial Post governed by CCS(Leave) Rules, 1972 to a post in an Industrial establishment governed by CDS(IE) Leave Rules, 1954, to carry forward their Leave Balance at their credit on the date of such appointment/transfer/promotion subject to the maximum limits of accumulation as laid down in Rule 26 of CCS(Leave) Rules, 1972.

2. The relevant part of the CDS(IE) Leave Rules, 1954 stands amended to that extent.
3. This will take effect from the date of issue of this letter.
