Subject: Promotion from the grade of Senior Accounts Officer (Group 'B') to the Junior Time Scale (Group 'A') of the Indian Defence Accounts Service on adhoc basis.

The Government of India, Ministry of Defence (Finance) have approved promotion of 7 (Seven) Senior Accounts Officers serving in the offices/organizations indicated against each in Annexure 'A' to this letter to the Junior Time Scale of the Indian Defence Accounts Service (scale of pay Rs. 15600-39100 plus Grade Pay Rs. 5400) **on adhoc basis**. The promotions are for a period of one year or till regular promotion to the grade are made or until further orders whichever is earliest. The Competent Authority has decided the postings on promotion in the offices/organizations as indicated against their names in the Annexure 'A'. The officers, may, therefore, be relieved of their present duties immediately with directions to report for duties in the new office of posting, as indicated in the Annexure 'A'. On reporting, the officer(s) may be **promoted to Junior Time Scale of IDAS on adhoc basis** and designated as ACDA/Dy.IFA/ACFA (Fys) etc. whichever is applicable. The promotion of seven officer shall take effect from **01.01.2012** (as indicated in Annexure 'A') or from the date of assumption of charge of the new post, whichever is later, provided no disciplinary/criminal case is pending against the officer's and they are not under suspension.

2. The officers on reporting in the new office of posting may also be requested to inform their date of joining, correspondence address, telephone nos. (official, residential & mobile) and email id on [hqadmin1-b@cgdamail.org](mailto:hqadmin1-b@cgdamail.org) for updation of the Pink List.


3. The promotion of the officers is purely on an adhoc basis. It neither bestows any claim on the officer(s) for regular promotion to the post nor service rendered in the grade will count for the purpose of seniority in that grade or for promotion to the next higher grade. The pay of the officer granted adhoc promotion will be regulated in terms of FR-22(I)(a)(1) read with FR-35.

4. Since the promotion is effective w.e.f. 01.01.2012 or from the date of assumption of charge of the post which ever is later, the officers may be relieved **immediately** and a copy of the relieving order may be forwarded to HQrs office by FAX for information of the CGDA. Further, relieving of the officers may not be withheld on the ground that a representation has been submitted for change of place of posting or on the ground that reliever has not reported/been posted. It may also be brought to the notice of the officers that no representation for change of posting etc. will be entertained in any case as all efforts have been made to accommodate individuals at their choice stations to the extent possible after due consideration of grounds mentioned in their respective representations. The Controllers may also ensure that representations are not unduly forwarded.

5. Transfer of 04 (Four) serving IDAS as indicated in Annexure 'B' to this letter has also been approved by the Competent Authority. Accordingly the officers' may be relieved of their present duties immediately, with the directions to report in their new office of posting.


6. TA and joining time as admissible under rules may be authorised to the officers.


