Subject: Willingness of participation in 10th All India DAD Table Tennis Tournament 2025-2026 (Men & Women) –reg.

The Competent Authority, DASC, HQrs office has approved to hold 10th All India DAD Table Tennis Tournament, 2025-26 (Men & Women) from 06.04.2026 to 08.04.2026 (tentative dates), to be organized jointly by PCDA(O) Pune and NADFM Pune.

2. The said Tournament will be organized under 3 three different categories, viz. "sports quota", "non sports quota" and "IDAS" separately for Men, Women and Mixed sub-category. The participant teams under "non sports quota" category shall comprise 3 men & 2 women players. All the matches will be played in accordance with laws of Table Tennis approved by Table Tennis Association of India.

3. NADFM/PCDA(O), Pune will arrange lodging/boarding facilities in designated hotels on payment basis, if opted by the players. The participants are requested to plan travel to ensure they reach Pune station on 05 April 2026, and leave Pune station only after closing ceremony in the evening hours of 08 April 2026. The accommodation and travel arrangement shall be accordingly arranged by NADFM/PCDA(O), Pune upon intimation.

4. All willing Table Tennis Sports Quota players and IDAS officers will have direct entry in the subject tournament. All offices under proforma control of CDA Guwahati are requested to send their players' entry through this office only.
