Subject: - Change in the date of holiday on account of Id Ul Zuha (Bakrid) – reg.



Please refer to para 3 of DoPT Office Memorandum under Reference (I), wherein it has been directed that for offices outside Delhi/New Delhi, the Central Government Employees Coordination Committees or Heads of Offices (where such committees are not functioning) can decide the date of holiday on account of Id Ul Zuha (Bakrid), depending upon the decision of the concerned State Government.

2. Government of Assam, vide their Notification under Reference (II), has stated that the Governor of Assam is pleased to declare 28th May, 2026 (Thursday) as public holiday on account of Id-ul-Zuha instead of 27th May, 2026 (Wednesday).
3. Office of the Pr. Accountant General (A&E) Assam, vide their Circular under Reference (III), has stated that – it is decided that holiday on account of Id Ul Zuha (Bakrid) will be on 28th May 2026 (Thursday) in place of 27th May 2026 for all Central Government Administrative Offices located in Assam State covered under CGE Welfare Co-ordination Committee.
4. Govt. of India, Ministry of Development of NER, North Eastern Council Secretariat, vide their Circular under Reference (IV), has stated that it has been decided to shift the holiday on account of Id-Ul-Zuha (Bakrid) to 28th May, 2026 instead of 27th May 2026 for all Central Government Organizations in the State of Meghalaya.
5. Accordingly, Officers-in-charge of all sections of Main Office, CDA Guwahati and all sub-offices under CDA Guwahati including IFA offices are requested to ensure wide circulation of the above mentioned change in the date of holiday on account of Id Ul Zuha (Bakrid) among officers and staff under their respective administrative control.
