Subject: Identification of Officers for creation of Pay Commission Cell.

Govt. of India has constituted a Commission for rationalization and review of Pay & Allowances, bonus, DCRG and other facilities/benefits, in cash or kind vide Gazette Notification No. 322 dated 03.11.2025. Accordingly, it has been decided to create a dedicated Pay Commission Cell at HQrs to examine, analyze and coordinate matters relating to pay, allowances and service conditions of Services and Defence Civilian Officers & staff.

2. In this regard, all Controllers are requested to identify and nominate suitable Dy.CsDA/ACsDA/SAOs/AAOs from their respective offices who possess experience and aptitude in establishment matters, pay fixation, rules and regulations and data analysis. The officers so identified should be capable of undertaking detailed examination of pay commission related issues and assisting in interpretation of rules and representations. Nominations from retired officers with their past experience and expertise in pay matters may also be forwarded separately.

3. The nominations should include the following details:

- i. Name, Account No. and designation of the officer
- ii. Present office of posting
- iii. Length of service
- iv. Experience of pay related work with regard to Services/Civilians
- v. Recommendations of the Controller

4. The nominations, duly recommended by the PCsDA/CsDA, may please be forwarded to this HQrs, latest by 28.02.2026 for further necessary action.
