

2. It has been decided to call for names of willing and eligible officers amongst SAOs/AOs for filling up the aforesaid deputation post in SPG, New Delhi. **While sponsoring the names, Controllers must ensue that** : (i) the particulars furnished by the Officer are correct (ii) the Officers must have stayed minimum 2 years at the present station (iii) the officers should not be under transfer (iv) the Officer should be below 45 years of age (v) the Officer has completed mandatory "cooling off" period of three years in case the Officer has recently served on a deputation post (vi) must enclose disciplinary/vigilance clearance certificate, integrity certificate, details of major/minor penalty (ies), if any, imposed during the last 10 years .

3. The nominations of willing and eligible candidates may be sent alongwith their (i) complete APAR dossiers in original containing upto date ACRs / APARs (ii) Service Records/book so as to reach this HQrs Office by **10.03.2026**.

4. PCsDA / CsDA offices are requested to make proper scrutiny of the received application as mentioned in para 2 above at their end before forwarding them to HQrs Office. The application received after the due date or found not eligible/incomplete will not be considered.



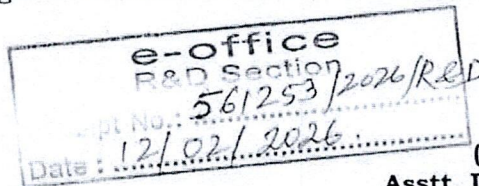
Sir,

We are in need of Ministerial Officer in the rank of Senior Accounts Officer / Accounts Officer on deputation basis to fill up the existing vacancies/vacancies arising upto December 2026. The terms and conditions of deputation are as under: -

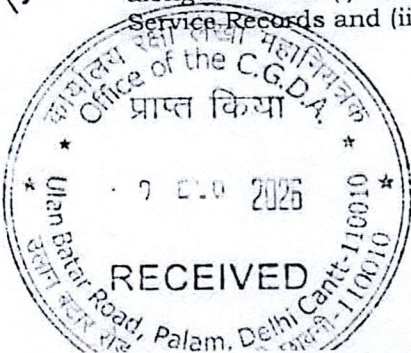
- Officers with minimum four years of service experience on regular basis are eligible.
- Age Limit:** Preferably below 45 years of age. However, if Officer(s) below 45 years of age is not available, forward nominations of above 45 years of age for consideration.
- S.A.O. / A.O. who are in the Pay Level 8 & 10 of Pay Matrix (as per 7th CPC) are eligible for subject deputation.
- The deputation will be governed by the provisions of DOP&T O.M. No. 6/8/2009-Estt (Pay-II) dated 17/06/2010. The deputationist will be entitled for Deputation Duty Allowance as per provision under the rules under reference.
- If he/she is found suitable for handling office work related to operational matters, he/she would be appointed in the Combatised posts of SPG after one month from the date of joining SPG, subject to availability of vacancies in the equivalent rank. On such appointment, they will be entitled to an allowance equivalent to 27.5% of their Basic Pay. Then, they will also be entitled for Dress Allowance.
- If the deputationist is not found fit for combatisation, he/she will have the option either to continue in SPG under general terms of deputation as indicated in (d) above or to revert to their parent department.
- The tenure of deputation will be six years, if appointed in the Combatised post after one month. Otherwise tenure will be three years.
- Those who attended pre-induction tests in SPG earlier, but could not be successful are eligible to apply only after completion of a gap of 06 months from the date of their last appearance for pre-induction test in SPG.
- The deputationists will be allotted hostel/family accommodation at SPG Complex, Dwarka, New Delhi from SPG Pool immediately on joining SPG. On such allotment they are liable to stay in the SPG Complex itself unless they are having General Pool accommodation. In case of Officers staying in their own house, HRA will be admissible only if SPG accommodation is not available.

2. It is requested that nominations of willing and eligible candidates may be sent alongwith their (i) complete APAR Dossiers in original containing upto date ACRs/APARs, (ii) Service Records and (iii) vigilance clearance certificate, so as to reach us at the earliest please.
