Subject: - Timely submission of Immovable Property Return (IPR) in respect of SAOs and AAOs for the year of 2025

Reference: - CDA Guwahati (AN-1B)'s letter No. AN/1B/720/IPR/Vol-XXII dated 31.12.2025

In pursuance of CGDA HQrs Office letter No. AN-II/2605/IPR/SAOs/2025 dated 22.12.2025, all SAOs and AAOs were instructed vide this office letter dated 31.12.2025 (referred to above) to submit their Immovable Property Return (IPR) for the year 2025 online only through SPARROW portal. The same was also reiterated through informal communication to ensure compliance by all officers concerned.

2. However, it has been observed that the IPRs of several officers for the year 2025 (as on 01.01.2026) are not reflected to the IPR Nodal Officer at CDA Guwahati (AN-1B). This may be due to non-submission through the SPARROW portal or other reasons. **A list of such SAOs and AAOs is enclosed herewith.**

3. All officers whose names appear in the attached list are required to:

(i) **Forward a copy of their IPR 2025** to AN-1B, Main Office, CDA Guwahati, *if they have already submitted it online through SPARROW*; or

(ii) **Fill the IPR 2025 offline** in the prescribed form and send it to AN-1B, Main Office, CDA Guwahati, alongwith **reasons for non-compliance** of instructions regarding online submission of IPR 2025 through SPARROW.

4. It may please be noted that a consolidated report in this regard is required to be submitted to HQrs Office within the stipulated timeline. Therefore, all concerned officers must ensure submission of the required information via return email at [cdaguwamjn1b.dad@hub.nic.in](mailto:cdaguwamjn1b.dad@hub.nic.in) latest by **06.02.2026, 15:00 hrs**, without fail.
