Please refer to HQrs Office above cited letters requesting your office to furnish a Monthly Report to HQrs Office by 15<sup>th</sup> of every month, in the prescribed format showing the progress of work related to post audit of fixation of pay and payment of arrears claims in regard to implementation of CCS (RP) Rules 2016.

- It is seen from the reports received from your office that the post-audit of claims/pay fixation/arrear claims on account of implementation of 7<sup>th</sup> CPC orders has still not been completed mainly due to non submission of claims by the concerned units. Hence, the concerned units may be asked to speed up the submission of claims/pay fixation proforma in respect of remaining cases. Further, the necessary action in respect of received claims may be expedited in your office and a report in the prescribed format as given in HQrs Office letter dated 10-08-2016 showing the updated position in this regard may be furnished immediately.
- 3. Moreover, as per MoF OM No 1-5/2016-IC dated 29-07-2016, the disbursement of arrears in respect of Govt employees on implementation of 7<sup>th</sup> CPC recommendations are to be paid without pre-check of the fixation of pay in the revised structure of pay, however, it may be seen from the reports of some PCsDA/CsDA that there are more than 1000 cases where arrears have not been paid till date. The reasons or the same may be intimated to HQrs Office.
