Please refer HQrs. Office letter cited above, wherein it was requested to expedite the revision of pension of pre-2016 Defence Civilian pensioners/ family pensioners so that the 100% completion target specified by the Ministry of Defence could be achieved by 31/03/2018.

2. A Review meeting was convened on 18.01.2018 in the Ministry of Defence, Department of Defence [D(Civ.II)] under the chairmanship of Joint Secretary(Estt) regarding progress of revision of pension cases of pre-2016 Central Civil Pensioners/Family Pensioners. In the meeting, the representative of MES intimated that total 28,127 LPC-cum-data sheets were forwarded to audit offices whereas only 11,177 cases were forwarded to PCDA (P) Allahabad as on 17<sup>th</sup> January 2018.

3. The fortnightly reports also reveal that pace of completion of revision of pension cases at field audit office level is very sluggish. It is therefore requested to direct the field audit offices under your jurisdiction to expedite the remaining cases of revision of pension and audit of LPC of pre-2016 Defence Civilian pensioners/ family pensioners.

4. The progress of completion of revision of pension cases may please be promptly reflected in the ensuing fortnightly report due on  $31^{st}$  January 2018 as well as in the subsequent reports for every fortnight.

5. Apart from informing the total number of revision of pension cases completed in the prescribed proforma, total number of cases completed in r/o MES organization may also be furnished below the report.
