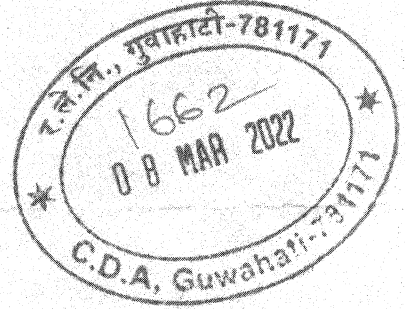

Audit of Service data entered in SPARSH application is required to be carried out on the basis of audited Service BOOK and other pension documents submitted by retirees to his HOO. Verification of pay by Pay user is also to be done from the last pay bills/Demand Registers etc held in PAO.

As such, necessary directions may please be issued to sub offices under your jurisdiction that are performing Pay and Audit roles in SPARSH for MES units/HOOs not to ask for physical copy of LPC cum Data Sheet to avoid delay in processing pension claims.


Subject: Implementation of SPARSH for Def Civ: MES Org.

Reference: CRO (O) MES Delhi Cantt letter No.CRO/4/15/SPARSH/93/COORD dated 25.01.2022. (Copy enclosed).

CRO (O) MES Delhi Cantt vide their letter dated 25.01.2022 cited above has reported that some Audit offices are asking hard/physical copy of LPC cum Data Sheet for processing pension claims in SPARSH for MES retirees.

2. It is intimated that after implementation of SPARSH, preparation and submission of hard copy of LPC cum Data Sheet duly filled in by HOO concerned has been dispensed with. Audit of Service data entered in SPARSH application is required to be carried out on the basis of audited Service Book and other pension documents submitted by retirees to his HOO. Pay verification is also to be done from the last pay bills/Demand Register etc held in PAO.


