Subject: Transfer: DAD Estt.: SAs/Aud./Clk : Bhutan Panel - 2016-17.

It has been decided by the HQrs Office, New Delhi vide their letter No.AN/X/10098/6/2016/BTN dated 13/05/2016 to call for volunteers amongst <u>SAs/Aud./Clks</u> for posting to **Bhutan** who fulfill the criteria as listed below:

- i) The applicant is eligible for only one tenure to Bhutan in the entire service.
- ii) The applicant needs to have 'Very Good' in the APARs for the last five years to be eligible for empanelment.
- iii) The applicant should not be facing any disciplinary proceedings and should not have earned any penalty including recorded warning at any time in their career.
- iv) They should have completed a period of three years after their last sensitive assignment.
