HQrs letter No. AT/II/2701/pre-2016/Pen Rev/Report dated 12/10/2017, 27/10/2017, 21/11/2017 and 29/11/2017 and letter o. AT/II/2701/Orders dated 10/11/2017 and 13/11/2017.

Please refer HQrs. Office letter dated 12/10/2017 cited above, wherein it was requested to forward separate ortnightly reports for civilians Non-DAD, civilians DAD and services in the prescribed formats (Annexure A, B & C) by 1st and 6th of every month.

Govt of India, Ministry of Defence (Department of Defence) through its ID No. 12(8)/2017-D(Civ-2) dated 22nd ovember 2017 has specified a target for HoDs to ensure completion of 80% of pension cases by 31/12/2017 and 100% ases by 31/03/2018.

On reviewing the progress reports for the fortnight ending on 31st December 2017 submitted by different controller fices, it is observed that the pace of completion of revision of pension cases is very sluggish. It is therefore requested to rect the field audit offices under your jurisdiction to liaise with the unit authorities to expedite the revision of pension of pre16 Defence Civilian pensioners/ family pensioners so that the 100% completion target specified by the Ministry of Defence ould be achieved by 31/03/2018.

Further, if all the cases related to revision of pension of pre-2016 Non-DAD and DAD civilian pensioners/ family

ensioners have been completed by your office, a completion report may please be furnished separately.

The reports are compiled and the progress of completion of cases is watched at various higher levels at the HQrs. ffice as well as the Ministry of Defence. It is therefore, requested to ensure that the reports in r/o civilians Non-DAD, vilians DAD and services (Annexure A, B & C) for the Fortnight ending on 15th Jan 2018 is received in this HQrs. Office by .00 AM on 16th Jan 2018 positively through email hqaudit.cqda@nic.in only.
