FIELD SERVICE CONCESSIONS TO TROOPS DEPLOYED IN OP RHINO: AMDIT TO AREAS COVERED

1. Pliref to the fwg:-

- (a) MoD letter No 37269/CI/AG/PS-3(A)/121/D(Pay/Services) dt 14 Jan 1994.
- (b) PS Dte letter No B/25552/Rhino/AG/PS-3(P) dt 29 Mar 2022.
- (c) Govt of Assam Notfn No HMA-19015/9/2019-Political(A)/120 dt 31 Mar 2022.
- (d) PS Dte letter No C/7036/R&H/SAPCS/2022 dt 10 May 2022.
- 2. Govt of Assam vide Notfin mentioned at Para 1(c) above, has superseded previous Notfin and declared only nine districts & one sub division as 'Disturbed Area'. Apropos, Fd Service Concessions as granted vide MoD letter No 37269/Cl/AG/PS-3(A)/121/D(Pay/Services) dt 14 Jan 1994 will be applicable to areas mentioned in Para 3(a) only. However, admissibility of revised R&H Alice is not linked to "Disturbed Area Notfin". Applicability of R&H Alice to a particular loc is given out in succeeding paragraphs.
- 3. The nine districts and one sub division where 'Disturbed Area' is still notified are as under:-
 - (a) <u>Disturbed Areas</u>.
 - (i) Tinsukia.
 - (ii) Dibrugarh.
 - (iii) Charaideo.
 - (iv) Sivasagar.
 - (v) Jorhat.
 - (vi) Golaghat,



- (vii) Karbi Anglong.
- (vii) West Karbi Anglong.
- (ix) Dima Hasao.
- (x) Lakhipur Sub Division of Cachar District.

(b) Implications.

- (i) Continue to be eligible for Op RHINO concessions as earlier.
- (ii) Applicability of revised R&H Allce wef 22 Feb 2019 will be as per PS Dte letter mentioned at Para 1(d) above. However, only one allce out of CI in Fd/ Revised R&H Allce can be claimed.
- (iii) 'Charaideo' only eligible for Cl Alice in Fd and other fd service concessions. Revised R&H Alices not applicable to 'Charaideo' as location not part of 132 locs mentioned in the MoD letter dt 21 Apr 2022 for implementation of R&H alices.
- 4. Due to Disturbed Area Notfn being restricted to only nine districts and one sub division, status of the bal 24 districts is now amended as under:-
 - (a) <u>Status of Cl in Peace Changed to Peace</u>. Districts as mentioned below have been re-classified as Peace Areas -
 - (i) South Salamara Mankachar.
 - (ii) Goalpara.
 - (iii) Kamrup.
 - (iv) Kamrup Metro.
 - (v) Marigaon.
 - (vi) Nagaon.
 - (vii) Hojal.
 - (viii) Karlmganj.
 - (ix) Hailakandi.

(b) Implications of Cl in Peace Changed to Peace.

- (i) Cl Alice (Offrs- ₹ 10,500/- & JCOs/ OR ₹ 6,000/-) stopped wef 01 Apr 2022.
- (ii) Applicability of revised R&H Allce promulgated vide MoD letter No 8(3)/2017/D(Pay/Services) dt 21 Apr 2022.
- (iii) All Op RHINO concessions like HRA, SPR etc withdrawn wef 01 Apr 2022.
- (c) Status of Cl in Mod Fd Changed to Mod Fd. Districts as mentioned below have been re-classified as Mod Fd Areas:-

- (d) Implications of CI in Mod Fd Changed to Mod Fd.
 - CI Alice (Offrs- ₹ 10,500/- & JCOs/ OR ₹ 6,000/-) stopped wef 01 Apr 2022. However, Mod Fd Area Allce @ ₹ 6,300 for Offrs & ₹ 3,600 for JCOs/ OR applicable.
 - Applicability of revised R&H Alice wef 22 Feb 2019 will be as per PS Dte letter mentioned at Para 1(d) above. However, only one alice out of Compensatory Modified Fd Area Alice// Revised R&H Alice can be claimed.
 - All locs continue to be eligible for Fd Service Concessions like HRA. (iii) SPR etc.
 - Majuli & Darrang eligible only for Mod Fd Area Allce and other Fd (iv) Service Concessions as revised R&H Allce at these two locs is not applicable vide MoD letter No 8(3)/2017/D(Pay/Services) dt 21 Apr 2022.
