



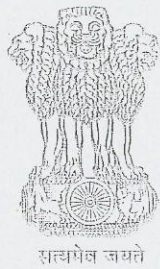

2. In the Managing Committee meeting of DCMAF, held on 28th June 2013 under the chairmanship of Defence Secretary, it has been, inter alia, decided that all members pay an additional Rs. 20/- per member per year, till the subscription rates are revised.


MESSAGE

The Defence Civilians Medical Aid Fund (DCMAF), established on 28th September 1953, provides financial assistance to its members in the event of specified medical contingencies befalling them or their dependents. The membership of the Fund is open to all Defence Civilian employees on payment of a nominal fee, either in lump sum or on an annual basis. The scope of benefits being provided by the Fund is expanded from time to time. The Fund has provided much needed relief to the employees and their families in their hour of distress.

In the year 2013-14, the Fund granted financial assistance of ₹ 1.25 crore to its members. At present, approximately 2.19 lakh Defence Civilian employees are members of the Fund. However, a sizeable number of civilian employees have still not joined it, apparently due to lack of awareness about the Fund.

On the occasion of the DCMAF Week to be observed between 28th September, 2014 to 4th October, 2014, I appeal to the Heads of all Defence Establishments, Federations and Associations under the Ministry of Defence to launch vigorous campaigns to make the employees aware of the benefits of DCMAF. I also appeal to all Defence Civilian employees to become members of DCMAF.
