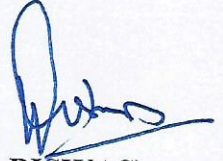
As we know that NPS is market linked scheme and delay of uploading leads to financial loss to subscriber. Instruction in this connection has been conveyed by this office through Important circular No.25 dated 08-04-2019 published in CDA Guwahati website which relay the latest Government Of India Gazette Notification dated 31-01-2019.

The matter of non generation of PRAN along with non/late uploading has been noticed from long period and has accumulated a huge amount in suspense which has been seriously viewed by higher authority. Necessary action to clear all the outstanding under head 00/020/61 may be taken and submit clearance report by 31-12-2019.

1. PRANs of new recruits not generated yet.
2. PRANs generated but NPS subscription not credited to the subscriber's account
3. Deductions lying in the suspense head individual wise.

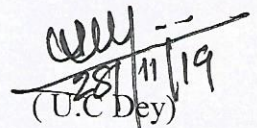
