





GRANT OF ACP/MACP BENEFITS TO THE TRADESMAN MATE


1. Reference this HQ letter No.
85610/47/ACP/IND(3)/Scheme/CSCC/79 dt 12 Sep 2014. P/35

2. It has come to the notice of this office that the policy guidelines regarding ACP and MACP Schemes are not being adhered to by some audit authorities properly and hence some offices try to give MACP benefits whereas it should be ACP benefits.

3. It is reiterated that before 01 Sep 2008, i.e., upto 31 Aug 2008, ACP was in force and ACP was to be granted in the scale / grade pay of the next higher post in the promotional hierarchy. In other words, all those tradesman Mates who are eligible for 1st and 2nd ACP, they will be given the grade pay of Rs. 1900/- and 2400/- (not 2000/-) respectively. But with effect from 1st Sep 2008, financial upgradation will be just in the next grade pay as per the hierarchy of grade pays as per 6th CPC. For example, if an employee got grade pay of Rs. 2400/- as 2nd ACP, he will get the grade pay of Rs. 2800 as 3rd MACP, if he is eligible for the same.



4. In view of above, it is emphasized that the ACP and MACP Schemes should be implemented in letter and spirit without any point of deviation.
