Subject: Exercising option by the members of DAD (SAS) Officers Association for Association membership under CCS (RSA) Rules 1993 and recovery of subscription for the year 2022-23.

Every SAS Officers desiring to become a member of DAD (SAS) Officers Association have to give in writing his/her consent as per specimen format enclosed. As per para 2.2, 2.3 &2.5 of DOP&T, Most Immediate OM No. 2/10/80-JCA dated 31st January 1994, option for DAD (SAS) Officers Association membership can be exercised by the AAOs/AOs/SAOs in the month of **April** each year and recoveries of membership subscription shall be made by the DDO in the month of **July**.

- 2. The <u>option once exercised will remain valid for all the years to come unless withdrawn or changed by the concerned individual</u>. Such withdrawal/change and option for new membership is permitted <u>only in the month of April every year</u>.
