Subject: Modification of the provisions relating to Travelling Allowance entitlements of armed forces personnel consequent to the recommendations of the 7th Central Pay Commission and Government - acceptance thereof.

Reference: This HQrs office's important circular of even no. dated 17.10.2017 vide which MoD's letter No. 12630/Mov C/242/D(Mov)/2017 dated 15.09.2017 had been circulated to all PCsDA/CsDA

In continuation of the above referred letter it is clarified that for regulating TA/DA claims related to permanent transfer, in cases involving transportation of personal goods by road ibid MoD letter (para 3 (iii) "Transportation of Personal Effects" in the Annexure) does not contain any mention of the criterion of weight of personal effects. Instead, only per kilometre rates have been mentioned therein, as per the armed forces personnel's pay levels.

2. Any quantum of personal effects can be transported by road, by the armed forces personnel, on permanent transfer. Their entitlement on this account would be the per kilometre rate multiplied by the distance between the residence at the old duty station upto the residence at the new duty station. Accordingly, it is reiterated that the above mentioned criterion of weight may not be applied while regulating ibid TA/DA claims.
