Learned counsel contends, inter-alia, that the action of the respondents in denying Dress Allowances to the applicants and effecting recovery of the amount paid for the years 2018-19 and 2019-20, without following the principles of natural justice, is arbitrary and illegal as they themselves, in pursuance of OMs dated 02.08.2017 and 31.08.2017, granted this benefit to the applicants. A prayer for restraining the respondents from effecting recovery, as an interim measure, is also made.

Issue notice to the respondents.

At this stage, Mr. Sanjay Goyal, Sr. CGSC, appears and accepts notice. He seeks and is granted four weeks time for filing written statement.

RECEIVED

This Federation vide Letter referred above have represented for extension of the payment of Dress Allowance to the Industrial Employees of Defence Establishments who were issued with protective clothing and protective equipments including various liveries, based on the recommendation of the 7th CPC. We were informed that MoD is actively considering the demand in consultation with the various Directorates. In the mean time based on the PCDA Chandigarh Letter dated 05.06.2018 Dress Allowance was already paid to the Employees. At present it has been brought to our notice that based on the instructions from CGDA the Accounts Authorities of MES have started recovering the amount of Dress Allowance already paid to the Industrial Employees.

In the above situation the affected employees of MES under Chief Engineer Headquarters MES Western Command Chandimandir have approached the Hon'ble CAT Chandigarh Bench and the Hon'ble CAT Chandigarh Bench in OA 60/1228/2019 vide its Order dated 27.11.2019



has directed the respondents including Defence Secretary that no recovery of the Dress Allowance already paid should be made till the next date of hearing. A copy of the above mentioned CAT Order is enclosed with this Letter for your kind ready reference.

Sir, you will appreciate that the above payment was made to the employees based on the direction of the concerned Authorities in the Government. Therefore, any action to recover the same at this juncture is not justified. Since, the CAT Chandigarh Bench have already stayed the recovery of the Dress Allowance already paid to the Industrial Employees, it is requested that MoD may kindly arrange to issue instructions for withholding the recovery of the Dress Allowance from the Industrial Employees and it is also requested that the issue may be settled at the earliest by issuing Government orders for payment of Washing Allowance to the Industrial Employees.
