- 2. At the outset, Sh. K Bhagabati, AO (AN) welcomed the Chairman and representatives of the Staff side and Office side.
- 3. Thereafter, all the agenda points put forward by the staff side were discussed at length in the meeting and the decision taken on the points are furnished as under:
- A. DECISION ON THE AGENDA POINTS RAISED BY GUWAHATI BRANCH OF AIDAEA (HQ) Kolkata,

Point No. 1 – Provision of LCD TVs with Cable connections in Suit-I, II, III and in the lounge at Ground Floor and First Floor as per the previous practice:

**Reply:** TV has already been installed with cable connection in Suit- I & II and are in working condition. Conditions of the TVs already installed in the lounge at Ground Floor & First Floor and in the Suit – III will be examined and if they are not working, fresh procurement will be made through GeM.

Point No. 2 - Repair/alteration of existing Inverter and Battery of Manash Guest House as the guests suffer during power cuts:

Reply: Condition of Inverter(s) and Batteries will be examined and if they are unserviceable, new sets of Inverter(s) and Batteries will be procured through GeM portal and installed.

Point No. 3 - Provision/Repair of Wash Basin, Utensil Rack, Window Panes/Steel Grills, Door/Windows wire mess, Floor/Wall tiles in Udayan Vihar Complex quarters:

Officer-in-Charge AN-V will take care of the matter in liaison with MES authority and the President, Residential Welfare Committee and conclude a contract against the same. Reply: Feasibility of coverage for the same through running Term Contract will also be explored.

Point No. 4 – Water supply to the water tanks of residential quarters from MES sub-division ground water reservoir:

Work in this regard is under progress and Officer-in-Charge AN-V MO Guwahati Reply: will follow the issue for an early solution of the problem.

### Point No. 5 - Revival of Gym established in Udayan Vihar Complex:
