

Transfer of Defence land to Airport Authority of India (AAI) and vice-versa on a notional licence fee of Re 1/- per sqm per annum.

Sir,

The requests for transfer of Defence land from Central Government Departments, State Governments and Organisations controlled by it as also local bodies, for execution of projects related to creation/up-gradation of Public infrastructure/utilities are regulated as per MoD policy letter issued vide MoD ID No. 11015/2/2012/D(Land) dated 2<sup>nd</sup> February 2016.

2. In continuation of the above policy, it has been decided with the approval of competent authority that in case infrastructure created by Airport Authority of India (AAI) on defence land after seeking working permission from MoD, are used by Services also, then working permission on such land will be granted on lease/ license basis on payment of nominal rent of Re 1 per sqm per annum. However, if the infrastructure are

used exclusively by AAI and the same are required for operational purposes by AAI, then normal lease rent @ 2.5 % of land value will be charged as per the existing policy.
