: Transfer Estt. DAD : Volunteers for Hard stations & North East Region (upto SAO level) and Tenure stations (only for SAO/AO).

As per transfer policy for manning of vacancies at hard stations, the Competent Authority decided to invite applications of volunteers from amongst SAO/AO/AAOs/ Sr.Adrs/Auditors/Clks, who have completed minimum 03 years (for AAO/SA/Adr./Clk./MTS) and 02 years (for SAO/AOs) at the present serving station, for posting to the hard stations and North East Region including Sikkim.

- In view of the above, details of volunteers may please be obtained and forwarded to this office. The officials may also be informed that only those, who will be having a residual service of at least 05 years at the time of posting, will be considered for posting to the hard station. In case: the applicant has applied for transfer to some other station through the volunteer list/panel, an endorsement may be made against his name in the remarks column of Annexure 'B-1'. Individuals serving in PIFA/IFA offices may forward their application through their respective proforma
- They shall invariably be repatriated to their first choice station. The order will be issued three months before completion of prescribed tenure. Three choice stations shall be called for and in the event it is not administratively feasible to post in first choice station volunteers will be posted to second or third choice stations.
- The tenure would be from 1st July 2023. Any deviation from the stipulated period would be an exigency of service and only in exceptional circumstances. If the date of joining is delayed the tenure will be extended accordingly. The minimum physical stay will be 20 months for 02 years tenure and 10 months for 01 year tenure.
- Individual should apply for specific stations (priority-wise) of this circular. 5.
- It is, therefore, requested to obtain & forward the application (in original) of all the volunteers in Annexure 'A-1' only along with connected data in Annexure 'B-1' by 16.06.2023. Annexure 'B-1' and 'C' containing individual details & service profile may also be forwarded in MS Office Excel through E-mail (admnix.cgda@nic.in or admnx.cgda@nic.in).


