

#### (A) Qualifications for AAO.

Officers /officials under the Central Government / Government of NCT Delhi/State Govt. and Autonomous Bodies

(i) holding analogous posts of Assistant Accounts Officer/ SO(Accounts) on regular basis;

Or

(ii) Junior Accountants/Senior Accounts/Auditor/ Sr. Auditors / Clerks who have qualified in both Part-I and Part-II of JAO(Civil) exam or equivalent examination with 5 year of regular service in the grade as on the date of the notification.

Or

(iii) Possessing the qualification or passing the SAS or equivalent examination conducted by any of the organized Accounts, Deptt. of Central/State Govt. /GNCTD and Autonomous Bodies.

### (B) Age
