

Subject matter was referred to the Ministry through our HQrs Office in terms of GOI MoD letter No. 01/(05)/2010-D(Pen/Pol) dt. 17.01.2013. Now, Department of P & PW OM No. 1/33/2012-P&PW (E)/9821, dt. 12<sup>th</sup> November, 2014 has clarified that "For all such claimants of family pension who are subject to dependency criteria, the family pension is not to be taken into account as income."


2. In view of above clarification, cases for grant of **dual family pension** require to be reviewed. Affected cases may be submitted/re-submitted to this office as usual.

Sub: Income criteria of family for dual family pension to family members (other than spouse) – regarding.

Ref: MOD ID No. 1(5)/2010/D(Pen/Pol), dated 30<sup>th</sup> September, 2014.

PUC is an ID Note from D/o Ex-servicemen Welfare seeking clarification whether one family pension payable under this department's OM No. 1/33/2012 P&PW (E), dated 16<sup>th</sup> January, 2013 is to be taken into account as income or not while adjudicating claim for second family pension in respect of same employee/pensioner under this OM.

2. It is clarified that the members of family who are eligible for family pension subject to dependency criterion constitute one class. There is no distinction between such members who are covered under O.M., dated 30<sup>th</sup> November, 2011 and such those members who are covered under O.M., dated 16<sup>th</sup> January, 2013. Therefore, for all such claimants of family pension who are subject to dependency criterion, the family pension is not to be taken into account as income.
