 - It may please be ensured that the IT return Proforma together with all supporting documents, likes copies of premium receipt, NSC, Infrastructure Bond, rent receipt etc should reach this office on or before 31/12/2014. belated receipt of the same shall not be entertained and the individual failing to submit IT return by the prescribed date will have to obtain refund, if any, from the ITO concerned.
