Subject: Annual Medical Examination for Group 'A' Officers – DAD – reg.

This is regarding Annual Medical Examination of Gp'A' Officers of Defence Accounts Departments.

2. As per DoPT OM No.21011/1/2009-Estt(A)-Pt dated 20.03.2013 and 15.01.2015, Ministry of Health and Family Welfare had entered into an agreement with the Hospitals in Delhi / NCR for conducting all investigations / diagnostic tests / consultations etc of the Central Civil Services of Gp'A' Officers of above 40 years of age, under Annual Medical Examination Scheme,

3. Since the above facility is applicable to only Gp'A' officers of Central Civil Services / Posts, a proposal to extend the said facility to the IDAS officers of the Department are under consideration. The salient features and proposed modus operandi of the scheme would be as under:

(i) IDAS Officers above 40 years of age, posted in Delhi / NCR region will be entitled for said Annual Medial Examination in the empanelled Hospitals as listed out by Ministry of Health & Family Welfare vide OM dated 01.10.2014, as per prescribed rates.

(ii) IDAS Officers above 40 years of age, and posted in cities other than Delhi / NCR but covered under CGHS, will be entitled for said examination at the Hospitals who have signed MoA with the Min of Health & Family Welfare, as per prescribed rates for Government / Semi-Government Hospitals.

(iii) For IDAS Officers above 40 years of age and posted in non-CGHS area, the PCDA / CDA concerned may identify one local Hospital / State Government Hospital/ Semi Government / PSU Hospital for said examination subject to prescribed schedule and rates or Hospital recognized under CS(MA) Rules.

(iv) PCDA/CDA/IFA and Sr.Dy.CGDA (AN) for HQrs Office will be authorized to issue requisite permission letter for said medical examination. The admissible financial limit for male officer is Rs.2000/- and female officer is 2200/-. Per annum.

(v) The expenditure could be met out of funds allotted under the head "Medical Expenses" and the Scheme could be implemented w.e.f 01.10.2015 for re-imbursement of expenditure.

4. In view of the above, it is requested that your views and relevant inputs on the above proposal may kindly be forwarded to HQrs Office latest by **30 September 2015** positively, for taking further appropriate action.
