joining in DAD.

संदर्भ/ Ref.: In continuation to this office Part-II Office Order No. 167 dated 19/05/2020.

In pursuance of HQrs Office letter No. AN/XIV/14162/Misc/DAD dated 17/03/2020 grant of MACP in respect of the Inter-departmental transferee clerks, who joined this department after receiving their 1st ACP in the previous departments and are presently serving in this organization has been revised/ amended vide this office Part-II O.O. cited under reference.

The approval for grant of financial up-gradation under MACP scheme as per Govt. of India, Ministry of Personnel, Public Grievance and Pension (DOP&T) OM No. 35034/3/2008-Estt(D) dated 19/05/2009, (DOP&T) OM No. dated 28/09/2016 and instruction received from HQrs Office vide Confidential Circular No. AN/XI/11051/MACP/2009/Vol-I dated 21/05/2009 and No AN/XI/12240/MACP/2019/Vol-I dated 08/11/2019 and No. AN/XI/11051/MACP/2019 dt 04/02/2020 has been reviewed, considered in the light of HQrs office ibid letters and DoP&T OM Nos. F.No. 13/9/2009-Estt (Pay-I) dated 21/10/2009; Para 2 of DoP&T OM No. 35034/3/2008-(D)(Vol-II) dated 01/11/2010 and No. 12/1/2016-Estt (Pay-I) dated 31/03/2017 and approved accordingly by the competent authority in respect of the following employees as per details enclosed as Annexure-'A'.

- 2. The implementation of the benefits are subject to the following conditions:
- (a) The financial benefit allowed under MACP shall be final and no pay fixation benefit shall accrue at the time of regular promotion in case it is granted in the same grade pay as under this scheme. However, at the time of actual promotion, if the promotion is granted in a post carrying higher grade pay than that under this scheme, no pay fixation would be available and only difference of grade pay would be made available.
- (b) The placement in the higher pay band and Grade pay / grant of one/ two financial benefits through up gradation under MACP scheme is only on personal basis to the employee and shall have no relevance to his seniority position. As such there shall be no additional financial up gradation for the senior employees on the ground that the junior employee in the grade got higher pay / grade pay shall therefore, neither amount to financial/ regular promotion nor to change in the existing designation or seniority position.
- (c) Fixation of pay is subject to change as per terms of 7th CPC recommendations. As per the 7th CPC, in the new Pay Matrix, the employees will move to the immediate next level in the hierarchy, fixation of pay will follow the same principle as that for a regular promotion in the Pay Matrix.
