Subject: - Observance of Vigilance Awareness Week, 2015.

As per guidelines of Central Vigilance Commission, Vigilance Awareness Week 2015 would be observed in the Office premise of the CDA Guwahati w.e.f. 26th October to 31st October 2015. This year the theme of the Vigilance Awareness Week is <u>"Preventive vigilance as a tool of Good Governance"</u>. The observance of Vigilance Awareness Week 2015 will commence with the pledge on 26th October, 2015 at 11:00 AM.

- 2. Good governance is about the processes for making good decision and their effective implementation. The main characteristics of good governance are transparency, accountability, following rule of law, being inclusive, effective and efficient. Good governance and preventive vigilance share several characteristics and therefore, preventive vigilance needs to be implemented as a tool of good governance. Application of preventive vigilance as a tool of good governance would not only result in removing the negative connotations attached with vigilance work but would also contribute positively towards the overall functioning of the organization.
- 3. Since the theme of Vigilance Awareness Week this year is 'Preventive Vigilance as a tool of Good Governance', this opportunity should be utilized to implement preventive vigilance in a big way.

In order to reach out to common public and convey message that corruption does not pay and also to highlight the positive role being played by the Vigilance Wing of this Organization through Preventive Vigilance, the Administration is working on organizing a **Open Session / Seminar** amongst executive authorities and their reps, vendors and customers which would be held during the Vigilance Awareness Week on 29th October, 2015 in the "Community Hall" at 10:00 AM.

5. To observe the Vigilance Awareness Week-2015 in befitting manner, the following events /Activities will also be organized in M.O. CDA Guwahati.

i) Poster/Banners Competition: Posters/ Banners from Vigilance/ Anti Corruption angle are invited from the interested Officers and Staff by 23rd October, 2015 to AN/IB Section of M.O. CDA Guwahati.

ii) Debate Competition: Debate competition on the subject "RTI has succeeded in minimizing Corruption in Govt. Department" will be held on 27th October, 2015 at 10:00 Hrs. in the 'Community Hall' of CDA Guwahati.
